- Status Update on Distribution to Growers

Reference is made to our status update dated 27 April 2026 ("**Our Last Update**").

Words stated herein, unless otherwise defined, shall have the same meaning as set out in Our Last Update.

Commencement of Distribution Exercise

We are pleased to inform you that the Liquidator of the Scheme has, since 22 June 2026, made distributions of the Net Sales Proceeds by way of electronic payments to eligible Growers who have submitted satisfactory proof of ownership, banking details and other required information.

The total amount available for distribution to the Growers is RM19,145,736.00. Therefore, the Net Sales Proceeds are distributed based on RM721.12 per Grower Plot for 26,550 eligible Grower Plots.

Winding Up of the Company

On 8 June 2026, Golden Palm Growers Berhad ("**the Company**") was wound up by the High Court and the Official Receiver has been appointed as provisional liquidator over the Company. Following the Company's winding up, all bank accounts which were operated by the Liquidator of the Scheme have recently been frozen.

Please be assured that we are taking the necessary steps to unfreeze the above bank accounts. As there are several stakeholders involved in this process, the unfreezing exercise may take longer than anticipated. Once the bank accounts have been unfrozen, the distribution process shall be resumed as soon as practicable. In the meantime, please be informed that the distribution entitlement to eligible Growers remain unaffected.
